Transfer of Insurance Business from QBE General Insurance (Hong Kong) Limited to QBE Hongkong & Shanghai Insurance Limited

As part of QBE Insurance Group's (QBE) aim to simplify its group structure and support the strategic growth of its business in Hong Kong, QBE General Insurance (Hong Kong) Limited (QGI) intends to transfer its whole of the general insurance business carried on in or from Hong Kong to QBE Hongkong & Shanghai Insurance Limited (HKSI) (Transfer). The proposed Transfer will be carried out using an insurance business transfer scheme pursuant to Section 25D of the Insurance Ordinance (CAP.41 of the Laws of Hong Kong), subject to the approval of the Hong Kong Insurance Authority (HKIA).

Please be reassured that this restructuring will not affect QBE's presence in Hong Kong. QBE has been serving Hong Kong for more than a century and will remain present in Hong Kong in the future. QBE will continue to provide a comprehensive range of non-life insurance solutions for both business and personal customers through an extensive network of professional insurance agents and brokers.

This Transfer is intended to be carried out with no impact (your QGI policy terms will not be affected), which will further benefit the continued stability and growth of the business of QBE Insurance Group.

Both QGI and HKSI are part of the QBE Insurance Group and are both registered general insurance companies in Hong Kong, authorized by the HKIA to provide insurance services to corporates, small and medium sized enterprise and individual customers.

We expect the proposed Transfer to take place at 00:01 a.m. on 1 October 2024, or such other date as QGI and HKSI may agree in writing and the HKIA may allow (**Effective Date**), following which, QGI will apply to the HKIA for withdrawal of its insurance authorization and thereafter will cease to be an authorized insurer in Hong Kong. QGI will be subsequently wound up and will close down its operation in Hong Kong.

If there are any additional named insureds or anyone else with entitlement to the benefits under your policy (such as individual members, if applicable, dependants, other named policyholders and sub-policyholders of the policy), please make them aware of the proposed Transfer and pass on this letter and attachments to them as soon as possible.

If, after reading this letter and the communication pack referred to above, you believe the proposed Transfer would adversely affect you, other named insureds, any of your dependants and/or any other named subpolicyholders of the policy, you have the right to send written representations concerning the proposed Transfer to the HKIA on or before 6 September 2024 at 19/F, 41 Heung Yip Road, Wong Chuk Hang, Hong Kong. Meanwhile, you can contact us by email, telephone or post, using the details shown at the end of this letter. We will pass any objections to the HKIA. Please quote the reference number at the top of this letter in any correspondence. We explain the process in more detail in section 2.4 of the enclosed FAQs.

Unless you have any concerns about the proposed Transfer or wish to object to it, you do not have to take any further action.
